# **Call to Order/Introductions**

Bell called the meeting to order at 1:06 p.m. Self-introductions were made.

# **Approval of the Minutes**

DeSouza made a motion to approve the February 4, 2020 minutes as submitted. Porter seconded the motion. The motion carried.

# **Current Marker Projects**

# • Conflict at Pistol River Marker

Garcia is still waiting to hear from Robert Kentta. Von Domitz updated Garcia that she communicated with the new manager of the state park where the marker is located. The manager had reached out to inquire about the sign on behalf of some community members. She informed him that the committee would not move forward on the project without input from the Confederated Tribes of Siletz Indians. She told the park manager that if the community members were anxious to get a replacement maker and weren't attached to that specific topic, the committee would be willing to review applications for alternative marker topics.

# • Broughton's Expedition

Porter has sent the text to his contact, Christian, with the Confederated Tribes of Warm Springs and is waiting for feedback from the Warm Springs historical advisory committee. Von Domitz suggested connecting with the Warm Springs representation at the Commission of Indian Services.

### Indian Marathon

Bell said that Tara (the graduate student working on this topic for her thesis) was out of the state and unavailable for the meeting, but she did send the information of she thought best covered the questions of posted to her by the committee. Von Domitz felt better that Tara did provide a competent context that she had reached out to the local tribes, such as, the Confederated Tribes of the Siletz, Cow Creek, and The Confederated Tribes of the Grande Ronde. She would still like Tara to attend the next meeting to discuss any further questions.

### Nez Perce Marker

Bell is waiting for feedback from Veronica RedStar. Von Domitz is also waiting to hear from Bobbie Conner. She will give her a call later this week.

# The Dalles to Canyon City Wagon Road

Von Domitz said that SeaReach could rebuild the frame for the sign for \$2,615. The other option is to completely redo the sign for just under \$7,000. Von Domitz has not had feedback from the city of Antelope for possible funding and the current climate makes future funding questionable. After discussion, the committee discussed the previous work done by the committee and the community desire to have the marker warrant spending the money to have the sign's frame rebuild and the marker replaced even without funding from the city.

Baldwin made a motion to approve rebuilding the frame and install The Dalles to Canyon City Wagon Road Marker. Washington seconded. The motion carried.

Von Domitz reported that HRA is in the middle of gathering their research and has been working closely with the Confederated Tribes of the Umatilla Indian Reservation gathering information.
